

Background



A Case of Access: The Smithsonian MacFarlane Collection is a documentary produced by the Inuvialuit Communications Society. It documents the trip a group of Inuvialuit took to the Smithsonian Institution to view the collection in 2009 and features interviews with the workshop participants and curator Stephen Loring.

- Value their cultural and northern identities
- Demonstrate understanding of the teachings of Elders about their culture and identity

- 1. What items in the collection would you like to use or make?
- 2. What do you hope Inuvialuit will gain from hearing about the collection from their own people as well as having access to the collection on the Inuvialuit Pitqusiit Inuuniarutait website?
- 3. How does the location of the collection at the Smithsonian Institution in Washington, DC prevent Inuvialuit from learning about their culture? How does having the collection located there help educate other cultural groups about the Inuvialuit culture?

post-activity

Imagine that you were on a trip to the Smithsonian Institution to visit the Macfarlane Collection. What item would you most want to hold, look at, and share with others? Write a paragraph with your choice, why you chose that particular item and what information you would want others to learn about it.

Procedure:

Watch the documentary A Case of Access and search The MacFarlane Collection.
